B. Rationale:

Physicians, Diagnostic and Imaging facilities are sending patients' reports on the internet in Jamaica and are unconscious of lurking dangers. Can patients bring legal action for release of their information on unsecured platforms and without their expressed and informed consent?

The Personal Health Information Code Of Practice has been implemented in certain places in the world and Jamaica is readying itself to do this too. What is this code and how will it affect our practice? Are there fines for breaches and can we still add our voice to its deliberations?
